Admission Procedure, Admission Factors and Criteria

1. Admission Procedure

- 1.1 The enrollment information of 11 preschools and kindergartens under Caritas Hong Kong has been published in the Kung Kao Po in August 2021. For the application procedures, please visit website: http:// tklns.caritas.org.hk/
- 1.2 In mid-October, the school will notify parents who have submitted the application form individually by letter or email, we will arrange a date and time to meet our new students and their parents. Appointments are generally arranged from November to January;
- 1.3 The school will send the admission result of the child by letter or email within about two weeks after the meeting with the parents.
- 1.4 The parents of students who have been admitted must pay a registration fee within the specified date; the waiting students will be included in the waiting list; after the unified registration day, if the school still has places, the school will accept those waiting students and notify parents to arrange for registration procedures.
- 1.5 The school will hold a parent meeting for new students in May every year to explain the admission arrangement; if there is a place in the future, the school will arrange the registration procedures for other waiting students;
- 1.6 According to the administrative guidelines of the organization, all application forms for students who have not been admitted will be stored for one year and then be destroyed. During this period, if parents have any enquiries, they can contact the school directly.

2. Interview arrangements for new students

- 2.1 In order to reduce children' s resistance to unfamiliar environments, please arrange an adult to accompany your child to the interview;
- 2.2 The interview will be conducted in Cantonese, through individual conversations with parents and children and observation of children during play;
- 2.3 Arrangements for admission applications for non-Chinese speaking children: When interviewing non-Chinese speaking children, our school may arrange interpretation services for applicants if needed, or parents and children may be accompanied by relatives and friends who could understand Chinese to assist in communication. For interpretation/translation services, please contact the school on 2674 3207.

3. Consideration of admission factors and criteria:

Due to limited places, the following are only considerations, the admission right is determined by the school

(Please note that due to places limitations, not all applicants who meet the priority consideration will be admitted)

- 3.1 The age of the child is 2 years and 8 months (preschool class) or 2 years old (preschool class) on September 1.
- 3.2 Parents agree with the mission and educational goals of the school;
- 3.3 Both parents need to go out to work and need full-time child care services;
- 3.4 Children's performance in interviews;
- 3.5 There are brothers and sisters who are current students of the school, which is convenient for parents to pick up and drop off;
- 3.6 There are brothers and sisters who are graduates of the school (who have completed K3);
- 3.7 have social and caring needs;
- 3.8 Those who live near TaKwuling, Fanling, Sha Tau Kok and Shenzhen, and nearby our school;

4. 2022/23 original registration certificate and registration fee

4.1 The registration fee for 2022/23 is HK\$1570. If the child is enrolled in the school in the new school year, the registration fee paid will be deducted/refunded from the tuition fee in September 2022. If parents decide to transfer their children to other school after registration, please notify the school in writing. The school will return the relevant registration certificate (for K class only), but the registration fee will not be refunded. After the registration card is returned, the school will no longer retain the place for the child.
