Interview

- 1. The Nursery School will arrange interview for all applicant.
- 2. Interviews will be conducted from November 2019 to January 2020.
- 3. Group interviews will be arranged. We will observe the child's behavior and interview with the parents.
- 4. Parents are required to accompany their child for the interview to ease the anxiety in facing a new environment.
- Interview will be conducted in Cantonese.

Admission Criteria and Factors for Consideration

1. For K1 class: the child should be at least 2 years and 8 months old when she/he is admitted in September 2020.

For N1 class: the child should be at least 2 years old when she/he is admitted in September 2020.

- 2. The alignment of the parents' view with our school mission and values.
- 3. The applicant from families in needs for whole day / long whole day edu-care service will be given due priority consideration.
- 4. Interview performance of the child
- 5. The applicant with sibling(s) currently studying in our school will be given due priority consideration.
- 6. The applicant has sibling (s) of our school's graduated alumni.
- 7. Residents in Ta Kwu Ling/ Sha Tau Kok / Shenzhen

As the number of school places is limited, please understand that not all applicants fulfilling the priority consideration will be guaranteed a school place. Our school has the final interpretation and decision on the factors concerned.

Announcement of Admission Results

We will inform parents of the admission results 2 weeks after the interviews by post / e-mail.

Registration Arrangements

- Successful applicants: Parents of K Class should complete the registration procedures for their child from 9 to 11 January 2020 ("Centralised Registration Dates") by submitting the original of the "2020/21 Registration Certificate (RC)" to our school and paying the registration fee.
- 2. The registration fee for 2020/21 is HK\$ 1,570. For those admitted children, the registration fee will be deducted from the school fee in September 2020.
- If parents cannot submit the "2020/21 RC" during registration, our school may not be able to complete registration for the child. Hence, parents are required to submit application for the Registration Certificate to EDB within the specified period (September to November 2019).
- 4. Should parents decide to change school after registration, please notify to us in writing. We will return the "2020/21 RC" but the registration fee will not be refunded. Upon obtaining the "2020/21 RC", our school will no longer keep the school place for the child.
- 5. Applicants on waiting list will be notified if there were availability after the Centralised Registration Dates.
